1.	Acknowledge that a horse or mule may, without warning or any apparent cause, buck, stumble, trip, roll, fall, rear, bite, run, make unpredictable movements, spook, jump obstacles, step on a person's feet, push or shove a person, saddles or bridles may
2.	loosen or break—all of which may cause the rider to fall or be jolted, resulting in serious injury or death. ACKNOWLEDGE THAT HORSEBACK RIDING IS AN INHERENTLY DANGEROUS ACTIVITY AND INVOLVES RISKS THAT MAY CAUSE SERIOUS INJURY AND IN SOME CASES DEATH, because of the unpredictable nature and irrational
3.	behavior of horses, regardless of their training and past performance. Acknowledge and willingly assume and accept full responsibility for all risk to personnel safety and welfare including danger of injury or death inherent in the handling or riding of the horse, and use of saddles, bridles, equipment and gear provided to me by the Releases.
4.	Release, discharge and promise not to sue the Releasees for any loss, damage, injury (including death) or cost to my or my child's person or property arising out of riding or handling a horse, or use of saddles, bridles, equipment and gear provided by the Releasees.
5.	Release the Releasees from any claim that such Releasees were negligent in connection with my or my child's riding a horse including but not limited to training or selecting horses, maintenance, care, fit or adjusting of saddles or bridles, instruction on riding skills or leading and supervising riders, which resulted in loss, damage, injury or both.
6.	Indemnify, and save and hold harmless the Releasees from and against any loss, liability, damage or cost they may incur arising out of or in and way connected with either my or my child's handling or riding the horse and/or use of any saddles, bridles, equipment or gear provided therewith resulting from or contributed to by my own negligence.
7.	Expressly agree that the foregoing release and assumption of risk, and indemnity agreement is governed by the laws of the State of Florida and is intended to be as broad and inclusive as is permitted by Florida law, and that in the event any portion of this Agreement is determined to be invalid or unenforceable for any reason, the balance of the Agreement shall not be affected or impaired in any way and shall continue in full legal force and effect.
8.	This Agreement does not release or waive Releasees' liability or assume the risk of or indemnify Releasees from grossly negligent, willful, wanton or intentional acts or omissions of Releasees
9.	Acknowledge that this document is a contract and agree that if a lawsuit is filed against the Releasees for any injury or damage in breach of this contract, I will pay all attorneys' fees and costs incurred by the Releasees in defending such an action.
